- I/We, the parent/guardian of the above named candidate for a position on the Natick Junior Redmen Youth Football Association, Inc., hereby give approval for him/her to participate in any and all football/cheerleading activities, including transportation to and from activities.
- I/We, are aware that participation in football or cheerleading may result in serious injuries, and protective equipment does not protect against all injuries to participants and I do hereby waive, release, absolve, indemnify, and agree to hold harmless the local Youth League, Natick Junior Redmen Youth Football Association, Inc. and the Board of Directors, the organizers, sponsors, coaches, participants and persons transporting my/our child whether the result of negligence or any other cause. I/We grant permission for my child to receive emergency treatment whenever necessary while participating in Natick Junior Redmen Youth Football Association, Inc. activities. I/We understand that in an emergency, whenever possible, an attempt will be made to notify his/her legal guardian.
- I/We accept full responsibility for any equipment that my/our child is allowed to use, and will pay to replace any and all equipment lost or destroyed except through normal wear and tear. I/We will not alter the equipment in any way as to render the manufacturer's warranties null and void. I/We will return the equipment washed and cleaned promptly at the end of the season as requested by the team.
- I/We agree to **furnish an original and certified true copy with raised seal (not a photocopy)** of my/our child's birth certificate during the first week of practice.
- I/We agree to **furnish a Statement of Physical Condition signed by a physician**, which states that my/our child is physically fit to participate in contact sports. The statement **must be dated after January 1, 2010** and furnished the first day of practice. The participant will not be allowed to practice without this doctor note.
- I/We agree to allow the Natick Junior Redmen to release photographs of my child for publicity in newspapers and on our web site. Individual children will not be identified in photos.
- I/We have read with my child the Natick Junior Redmen Zero Tolerance Policy, printed on backside of this application and understand fully that if not followed could result in my child's termination from this program.**
